Customer Survey Sweepstakes  
2010 Official Rules

THIS SWEEPSTAKES IS OPEN ONLY TO LEGAL RESIDENTS OF THE UNITED STATES (EXCLUDING PUERTO RICO) AND LEGAL RESIDENTS OF THE PROVINCE OF ONTARIO CANADA WHO ARE BOTH LOCATED IN THEIR STATES OR PROVINCE OF RESIDENCE AND ARE 18 YEARS OF AGE OR OLDER AT THE TIME OF ENTRY.

**NO PURCHASE NECESSARY. PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.**

1. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the United States, except Puerto Rico, and legal residents of the Province of Ontario, Canada, age 18 or older at the time of entry. Officers, directors, employees and agents of any of Panera, LLC and Panera Bread ULC (collectively "Panera") and Paradise Bakery & Café, Inc. ("Paradise") (collectively, the "Sponsors"), their affiliated companies and agencies, licensed retailers and wholesalers, The Sweepstakes Center, third party survey processing vendors, and the immediate families of each are not eligible. Different markets may have different phone numbers/websites related to entering this contest in those markets, however all rules for a particular month apply to the same monthly sweepstakes, not different or individual sweepstakes. Sweepstakes governed by U.S. law and subject to all applicable federal, state, provincial and local laws and regulations. Void where prohibited by law.

In the event of a dispute over the identity of an online entrant, entry will be deemed submitted by the "Authorized Account Holder" of the e-mail address submitted at time of entry. Authorized Account Holder means the natural person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Entry materials/data that have been tampered with or altered, or mass entries or entries generated by a script, macro or use of automated devices, are void. **By Phone:** To enter by telephone, for Panera, call toll-free 1-877-467-8436 or 1-877-689-1868 and for Paradise, call toll-free 1-877-884-2079 during the Sweepstakes Period and follow the instructions to complete the survey and/or to enter the Sweepstakes. **By Mail:** To enter by mail, and without completing the survey, hand print (or type) your name, address, day and evening phone numbers, e-mail address (if any), and age on a 3" x 5" piece of paper and mail it in a hand-addressed envelope to "Panera Bread and Paradise Bakery & Café, Inc. Customer Survey Sweepstakes, The Sweepstakes Center, P.O. Box 16349, Rochester, NY 14616. Mail-in entries must be postmarked by July 27, 2010 and received by August 10, 2010. One entry per hand-addressed outer envelope. Photocopied, illegible, or mechanically reproduced entries are not eligible.

3. **PRIZE:** One (1) Grand Prize winner will receive \$2,000 (if a U.S. winner prize will be awarded in U.S. dollars and if a Canadian winner prize will be awarded in Canadian dollars.). No substitution for the prize by winner; Sponsors may substitute a prize of equal or greater value in its sole discretion. Taxes associated with the acceptance of the prize are the sole responsibility of the winner.

4. **DRAWING:** The winner will be selected on or about August 15, 2010 in a random drawing conducted under the supervision of The Sweepstakes Center, a judging agency whose decisions are final and binding.
